

The approvals in 2016 were made on the basis of expressions of interest received in 2015 but due to a number of different circumstances at the end of 2015, including significant flooding across many parts of the country, the scheme didn't go ahead at that time.

Mayo Local Authority has completed the project but has advised that when undertaking the works significant levels of unexpected costs arose due to unforeseen reinstatement works being necessary along parts of the rail line and has asked this Department if it would consider

providing some additional funding to defray the additional costs incurred. The overall additional amount indicated by Mayo LA is €147,550.

Mayo has been a significant beneficiary under all of the rural schemes in the recent past but has also, for the most part, delivered on very good projects. I recommend that 80% of the funding requested be provided.

The norm as regards the ratio of funding to overall costs is generally 80:20 and it would be worth considering making 80% of the requested €147,550 i.e. €118k available on this occasion, as the original scheme was based on expression of interest level information only and hadn't necessarily been fully scoped out.



As requested by the Minister, this note provides a summary of the status of projects which have requested additional funding support in the last couple of weeks.

Kiltimagh Velo Rail - Rural Recreation 2016

€180,000 in funding was approved for Mayo Local Authority under the <u>2016</u> Rural Recreation scheme to develop a Velo Rail project in Kiltimagh, Co Mayo.

Mayo Local Authority has completed the project but has advised that, when undertaking the works, significant levels of unexpected costs arose due to unforeseen reinstatement works being necessary along parts of the rail line. The Council has asked this Department if it would consider providing some additional funding to defray the additional costs incurred. The overall additional costs indicated by the Local Authority is €147,550.

In line with the norm for the Rural Recreation Scheme, a maximum of 80% of the total cost could be paid by the Department if this request were to be acceded to. The Department's contribution in this case would be €118,000. This would bring the Department's total investment in the Velo Rail project to €298,000 and make it the highest supported project from a Local Authority under the 2016 scheme.

Only Coillte and Waterways Ireland received higher amounts of funding under the 2016 scheme.

A difficulty with this request is that the project has been completed and paid for, but the Council did not signal any issue in relation to the increased costs in the course of the project. Nor did the Council make an application for the project under the 2017 Rural Recreation Scheme. As requested by the Minister, this note provides a summary of the status of projects which have requested additional funding support in the last couple of weeks.

Kiltimagh Velo Rail - Rural Recreation 2016

€180,000 in funding was approved for Mayo Local Authority under the <u>2016</u> Rural Recreation scheme to develop a Velo Rail project in Kiltimagh, Co Mayo.

Mayo Local Authority has completed the project but has advised that, when undertaking the works, significant levels of unexpected costs arose due to unforeseen reinstatement works being necessary along parts of the rail line. The Council has asked this Department if it would consider providing some additional funding to defray the additional costs incurred. The overall additional costs indicated by the Local Authority is €147,550.

In line with the norm for the Rural Recreation Scheme, a maximum of 80% of the total cost could be paid by the Department if this request were to be acceded to. The Department's contribution in this case would be €118,000. This would bring the Department's total investment in the Velo Rail project to €298,000 and make it the highest supported project from a Local Authority under the 2016 scheme.

Only Coillte and Waterways Ireland received higher amounts of funding under the 2016 scheme.

A difficulty with this request is that the project has been completed and paid for, but the Council did not signal any issue in relation to the increased costs in the course of the project. Nor did the Council make an application for the project under the 2017 Rural Recreation Scheme. Of the four projects outlined above, this project seems to have the least compelling case for additional support.
